DAY 1 THURSDAY, JULY 4

FLIGHT TO DUBLIN

Today we will transfer to the airport for our overnight flight to **Dublin, Ireland**. **Note:** The airport location and airline will be confirmed nine months before departure.

DAY 2 FRIDAY, JULY 5 CORK (Dinner)

Upon landing in the Emerald Isle, we will be met by our favorite Irish driver/guide and board a deluxe motorcoach to begin our exciting adventure. As we journey south toward Cork, our first stop will be at the **Irish National Stud and Gardens** for a private guided tour. This state-run thoroughbred horse breeding farm has produced many winners for the Crown and is home to many retired equine superstars. The neighboring Japanese Gardens were planned to symbolize the "Life of Man" and are now world-renowned as the finest Japanese Gardens in Europe. Then we are off to the **Rock of Cashel**, a historic site that served as the seat of kings and medieval bishops for 900 years and flourished until the seventeenth century. Brian Boru was crowned King of Munster here in 977 and later became High King of Ireland in 1002. Legend has it the devil took a bite from the mountain and spat it back out. It landed in the middle of Tipperary's countryside and became the Rock of Cashel! After a full day, we'll settle into **The River Lee Hotel** in **Cork** for a two-night stay. Take some time to freshen up before we gather for a wonderful welcome dinner.

DAY 3 SATURDAY, JULY 6 CORK (Breakfast)

Enjoy breakfast at the hotel and time to relax before we head to the **Old Jameson Distillery** to learn about the hard-working people and field-to-glass processes responsible for the whiskey that bears John Jameson's name. Our tour of the old distillery will introduce us to the machinery and manual tools used in the past and the giant waterwheel which once powered all the machinery. The tour will end at the Jameson bar for a tasting. With the taste of delicious Irish whiskey on our lips, we'll continue on to the delightful little town of Kinsale tucked neatly into an Irish harbor and famous for its brightly painted rows of shops. Here we will visit a **small crystal cutting shop** established in 1992 by master cutter Gerry Daly. The master cutters are of Waterford fame and practice the skill of deep cutting crystal that is a dying art today. The return to the hotel for an evening at leisure will round out our day.

DAY 4 SUNDAY, JULY 7 KILLARNEY (Breakfast, Dinner)

After our hotel's filling breakfast, we'll say goodbye to Cork and begin the day's sightseeing as we make our way toward Killarney. A visit to Ireland would not be complete without a stop at **Blarney Castle**. We will follow in the footsteps of countless world leaders, literary giants, and movie stars as we climb the stairs to kiss the famous Blarney Stone that promises the gift of eloquence, or "the gift of gab" as the locals would say! The gardens at the castle are gorgeous and a wonderful alternative for those who wish to skip the climb to the castle ramparts. Afterward, we will enjoy a little retail therapy at the nearby **Blarney Woollen Mills** where traditional Irish wares such as Belleek, Waterford Crystal, Celtic jewelry, and woolen knitwear await. Our day will come to an end in the fun-loving town of **Killarney** as we check in to our accommodations at the **five-star Great Southern Killarney Hotel** for the next two nights. Enjoy the afternoon at leisure followed by a lovely dinner served at this beautiful hotel property located in the heart of this charming town.

DAY 5 MONDAY, JULY 8 KILLARNEY (Breakfast, Lunch)

Today's tour will have us exploring the Irish countryside and the sites at the beginning of the **Ring of Kerry**. A stop in **Kenmare** will include a delightful lunch overlooking a peaceful and quiet Atlantic inlet. The afternoon will begin with a visit to a **traditional working sheep farm**. The farm is run by a father and son and has been in the family for 150 years. These accomplished shepherds will show us some varieties of sheep that are raised in Ireland and also demonstrate how they move their flocks with well-trained sheep dogs. Next up is **Killarney National Park** and the **gardens of Muckross House**. At this magnificent Victorian mansion, one can find a rock garden on a natural outcrop of limestone which has winding steps and small paths to enjoy the collection of dwarf conifers and shrubs. Vistas of grass lead the eye through mounds of mature rhododendrons punctuated by the boles of Scots pine. From here we will hop aboard one of Killarney's famed **horse-drawn jaunting carts for a breathtaking ride** through the park. Once back in Killarney, the evening is yours to explore and have dinner on your own. Within walking distance of our hotel there are dozens of fun Irish restaurants to try and countless pubs with great food and lively music!





DAY 6 TUESDAY, JULY 9

GALWAY

(Breakfast, Dinner)

We depart Killarney after breakfast this morning, heading north to ferry across the Shannon Estuary and then drive through **the Burren**, one of the most remarkable geological formations in Ireland. The Burren is famous for its lunar-like limestone and unique flora, including the approximately twenty species of orchids growing wild here! Our journey along the craggy coastline will include a stop at the aweinspiring **Cliffs of Moher**. Here we will witness the incredible 700-foot wall of rock that rises from the Atlantic Ocean and stand high on the cliffs to catch a glimpse of the jaw-dropping view that has inspired artists, musicians, and poets for generations. We'll then head to the **five-star Glenlo Abbey Hotel and Estate** to check in and freshen up for dinner on the Abbey property.

DAY 7 WEDNESDAY, JULY 10

DONEGAL

(Breakfast, Lunch)

Relax on the short, yet scenic, journey north to **Ashford Castle**, once owned by the Guinness family. It was on these historic grounds that John Ford filmed *The Quiet Man*, starring John Wayne and Maureen O'Hara. We will **meet the falconer at Ashford for a "Hawk Walk"** on the castle grounds to learn how to feed these stunning creatures, call them to our gloved arms, and send them off again! An elegant lunch will cap off our time at Ashford before we make our way north toward Donegal with a stop at the historic **Tobernalt Holy Well**. This natural spring is set in a primeval forest and was used as a place of worship in the hills during the penal times of Ireland. Our final destination this evening is **Lough Eske**, the lovely castle where we will spend the next two nights. Tucked into the magnificent green lands of the Irish countryside, this splendid five-star castle hotel is waiting for our arrival. The evening is yours to have dinner on your own, relax, or take a leisurely stroll around the castle.

DAY 8 THURSDAY, JULY 11

DONEGAL

(Breakfast, Dinner)

Today you are free to do as you wish! Lough Eske offers easy access to golf, fishing, lakeside strolls, horseback riding on the beach or forest trails, and the slower-paced charms of Irish village life. The hotel can help you arrange activities such as the famous "Bluestack walkway," visiting a WWII crash site in the Bluestack Mountains, walking the Wild Atlantic Way, wildlife watching, and much more. Bikes are available to rent at Lough Eske with many great trails around the lake and through the mountains. Visit nearby Belleek Pottery or indulge in a little shopping time in Donegal, including a visit to a Donegal weaver for some fine-crafted, hand-woven tweed products. If you'd like to simply enjoy a quiet day, spend time at the hotel exploring the magical grounds or relaxing in the wonderful spa. Be sure to pack your swimsuit! This evening our group will come back together for dinner in an elegant setting.

DAY 9 FRIDAY, JULY 12

DUBLIN

(Breakfast)

After breakfast we'll leave our delightful castle and head toward Dublin. Along the way, we will make a stop at the **Corlea Trackway Visitor Centre**. While removing peat from the bog in 1984, a great timber roadway that had been buried for centuries was uncovered. Tree ring analysis revealed the trees used for this roadway were felled in late 148 BC or early 147 BC and identified the roadway as the only known example of an Early Iron Age road. Inside the center is a stretch of the road that has been preserved. We will then continue on to **Dublin** to check in to the **Riu Gresham Hotel** for the next two nights. Dinner this evening is on your own at one of the dozen great eateries located right outside our door!

DAY 10 SATURDAY, JULY 13

DUBLIN

(Breakfast, Dinner)

After breakfast we will begin a **panoramic sightseeing tour** including O'Connell Street, Phoenix Park, and Leinster House. Due to the renovation of Trinity College's library, we'll visit the **Book of Kells** at its temporary exhibit. The Book of Kells contains a Latin text of the four gospels copied and decorated by Irish monks around the year 800 AD. Afterward, enjoy time on your own for lunch and exploration. Our hotel is perfectly located to allow for a leisurely walk to Dublin's top museums, the Guinness Storehouse, and many wonderful restaurants and shops. This evening our group will gather for a delightful farewell dinner planned as a very special experience!
